1. The Borough Council of Dudley (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 124 (1) (d) and part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act of 1984”) and of all other powers them enabling in that behalf, and with the consent of every authority and person responsible for the maintenance of the roads affected by this Order and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order;

**PART I**  
**GENERAL**

Citation and commencement

2. This Order shall come into operation on the 7<sup>th</sup> day of July 2008 and may be cited as The Borough Council of Dudley (Off Street Parking Places) (Consolidation) (Number 2 type) Order 2008.

Interpretation

3. Any reference in this Order to a numbered article or to a numbered schedule is a reference to the article or to the schedule bearing that number in this Order.
4. In this Order:  
“Council” means The Borough Council of Dudley and includes any parking services contractors or authorised agents appointed by or acting on behalf of the Council for the purposes of any function under the provisions of this Order;  
  
“daily charge” means the charge imposed by the Council for parking in a parking place on any one day and for a specified period of time as is identified in the scale of charges specified by notice in the parking place;

“disabled persons badge has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000, as amended;

“driver” in relation to a vehicle parked in a parking place, means the person driving the vehicle at the time it was parked in the parking place;

“expiry time” is the time indicated on the Pay and Display Ticket and is the time by which the Vehicle must leave the Parking Place;

“motorcycle” has the same meaning as in Section 136(4) of the Act, but for the purpose of this Order does not include a motorcycle with sidecar attached;

“Order” means The Borough Council of Dudley (Off-Street Parking Places) (Consolidation) (Number 2 type) Order 2008;

“owner” in relation to a vehicle, means the person by whom such vehicle is kept and used. In determining who was the owner at any time it shall be presumed that the owner was the person named in the vehicle registration document as the registered keeper of the vehicle or the person who has the use of such vehicle in the course of his / her employment and who is entitled to use such vehicle as though he / she were the registered keeper thereof;

“park” refers to a vehicle stopping and remaining stationary for any period of time whether or not the driver is in the vehicle and a vehicle shall be deemed to park for any period in the same parking place or parking bay (as the case may be) if any part of it is below the vehicle or the vehicle’s load (if any) whether or not the vehicle is moved during that period;

“parking bay” means any area of parking place which is provided for the leaving of a motor vehicle of a class specified and indicated by markings on the surface of the parking place or signed or otherwise indicated by signs or other structure whatsoever placed or erected in the parking place;

“parking place” means any area of land as specified by name in The Schedule;

“pay and display ticket” means a ticket issued by a ticket machine located in the parking place in which the vehicle has been parked or issued by a person nominated by the Council on payment of a charge and valid for a parking period as advertised at that parking place;

“penalty charge” means a charge imposed by legislation in respect of parking contraventions that are subject to civil enforcement and which has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

“penalty charge notice” has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

“permitted vehicle” means a mechanically propelled vehicle the unladen weight of which does not exceed 30 cwt (1524kg) and which is less than 6’6” (1.98m) in height or motorcycle;

“relevant position” means:

- (i) In respect of a disabled badge-
  - (a) in the case of a vehicle fitted with a front windscreen, the badge is exhibited on the dashboard or fascia of the vehicle, or
  - (b) in the case of vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the vehicle,  
so that the front of the badge is clearly legible from outside the vehicle,
  
- (ii) In respect of a pay and display ticket or season ticket-
  - (a) in the case of a two-wheeled motor cycle having a sidecar attached thereto, in a conspicuous position on the vehicle in front of the driving seat; and in the case of all other vehicles:-
  - (b) (i) where the vehicle is fitted with a front glass windscreen inside the windscreen or in a conspicuous position facing forwards; or
  - (ii) where the vehicle is not fitted with a front glass windscreen, in a conspicuous position on the vehicle,  
so that the amount paid and the date and time of expiry of the ticket on the front of the said ticket or tickets is clearly visible;

“ticket machine” means an apparatus of a type and design approved for the purpose of the Act, being apparatus designed to indicate the time by a clock and to issue pay and display tickets which show that a payment has been made of an amount or for a period specified thereon and which specify the date and, either the time of such payment, or the expiry time at which the vehicle must leave the parking place;

“vehicle” means permitted vehicle;

5. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
6. Unless the context otherwise requires words denoting the singular shall include the plural and vice versa and words denoting the persons shall include either gender, bodies corporate, unincorporated associations and partnerships and all other legal entities.
7. The Interpretation Act 1978 shall apply for the interpretation of this Order.

## **PART II**

### **DESIGNATION AND USE OF PARKING PLACE**

#### Use of land and Parking Place

8. Each area of land specified by name in The Schedule may be used, subject to the following provisions of this Order, as a parking place for such classes of vehicles, in relation to that area by notice in the parking place.
9. Where in the schedule a parking place is described as available for vehicles of a specified class or vehicles to be parked in a specified position, the driver of a vehicle shall not permit it to park in that parking place unless it is of the class and in the position as specified.

### Classes of vehicles

10. No person shall cause or permit a vehicle to be parked in any parking place unless it is a mechanically propelled vehicle the unladen weight of which does not exceed 30 cwt (1524kg) and which is less than 6'6" (1.98m) in height or motorcycle.

### Maximum Period of Stay

11. Where by notice in the parking place, a parking place is described as available on specified days, during specified hours or for a maximum period of stay, no person shall cause or permit a vehicle to park in that parking place on any day, during such hours or for any period other or longer than those specified.

### Period of no return

12. Where by notice in the parking place, a parking place is described as having a period within which a vehicle may not return, no person shall cause or permit the vehicle to wait again in that parking place until the expiry of that specified period.

### Parking bays for specific classes of vehicle

13. No person shall cause or permit any vehicle to park in such part of a parking place as is marked by signs, lines, studs or other indications so as to indicate its provision as a parking bay for:-
  - (a) a motorcycle, unless the vehicle is a motorcycle without a sidecar attached thereto;
  - (b) a disabled persons vehicle, unless there is displayed on the vehicle in the relevant position a disabled persons badge.

### Stop engine

14. The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in a position in the parking place, and shall not start the engine except when about to change the position of the vehicle in or depart from the parking place.

### No selling

15. No person, without the written permission of the Council, shall use the vehicle whilst it is in a parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services

or for the purposes of advertising or promoting any cause, event or other matter whatsoever or for the distribution of leaflets or other materials.

16. For the purpose of repairing servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place.

#### Power to close or suspend parking places

17. (1) Any person authorised by the Council may suspend the use of a parking place or any part thereof whenever he considers such suspension or variation is reasonably necessary.
- (2) Any person suspending the use of a parking place or any part thereof in accordance with the foregoing provisions of this article shall thereon place or cause to be placed in or adjacent to that parking place or that part thereof a notice or traffic sign indicating in the case of suspension that the use of the parking place or that part thereof is suspended and that parking by vehicles is prohibited.
- (3) The Council at its discretion may suspend the use of all or any part of a parking place and thereafter may designate all or part of such parking place to be reserved for use only by particular vehicles or organisations and may apply such conditions and charges as it deems appropriate.
- (4) No person shall cause or permit a vehicle to be parked:
  - (a) in a parking place or any part thereof during such periods that the use of that parking place or that part thereof is suspended and during such period as there is in or adjacent thereto a notice or traffic sign placed in pursuance of paragraph 2 of this article;
  - (b) in any part of a parking place marked as being designated by the Council in pursuance of paragraph 3 of this article unless with the express written permission of the Council.

**PART III**  
**CHARGES FOR PARKING**

Payment of daily charge

18. The driver of a vehicle parking a vehicle in any parking place shall pay the appropriate daily charge for parking as specified by notice in the parking place in the manner prescribed by the notice.

Pay and display parking places

Payment

19. Save as provided in this Order, where the driver of any vehicle parks that vehicle in a parking place in which the "Pay and Display" system operates, he shall pay the appropriate charge as specified by notice in the parking place by the insertion in the ticket machine of a decrementing card or a coin or coins of the appropriate denomination making up the amount of the charge for the period for which payment is being made, and where more coins than one are required they shall be inserted in the ticket machine immediately one after the other.

Display ticket

20. Once a Vehicle has been parked within a pay and display parking place the driver of the vehicle shall display the pay and display ticket issued at that parking place in the relevant position on the vehicle in respect of which it was issued during the entire period that the vehicle is parked in the parking place.

Validity of pay and display tickets

21. A pay and display ticket is not transferable from one vehicle to another and on any such transfer the pay and display ticket ceases to be valid.
22. A pay and display ticket is valid only in the parking place in respect of which it was issued.



#### Expiry of parking period

23. The expiry of the period for which the appropriate charge has been paid shall be indicated when the time shown on the clock of the issuing ticket machine is later than the expiry time shown on the pay and display ticket displayed.

#### No pay and display ticket displayed

24. If at any time while a vehicle is parked in a parking place no pay and display ticket is displayed on that vehicle in the relevant position it shall be deemed that the charge has not been paid.

#### Ticket machines out of order

25. If at the time when a vehicle is parked during the charging hours in a parking place and the nearest ticket machine in that parking place is out of order, then a ticket shall be obtained from another ticket machine within the same parking place (where provided).

#### Absence of ticket machine

26. If at any time when a vehicle is parked in a parking place during the charging hours there is no ticket machine at the parking place, or all the ticket machines at that parking place are out of order, vehicles may be parked in a parking place but may not be parked for longer than the maximum period of parking in that parking place as advertised at the parking place.
27. If at any time when a vehicle is parked in a parking place during the charging hours there is no ticket machine at the parking place, or all the ticket machines at that parking place are out of order, the driver of that vehicle shall be exempt from purchasing a pay and display ticket.

#### Season tickets

28. Season tickets are available from the Council at the appropriate fee, for a vehicle of a specific class and for a specific parking place(s) subject to conditions, all determined from time to time by the Council.
29. A person purchasing a season ticket shall state the registration mark of the vehicle in respect of which he is purchasing such season ticket, and when issued, such season

ticket shall not be used for any vehicle other than the one bearing the registration mark quoted.

30. A season ticket is only valid in the parking places in respect of which it was issued and up to the date of expiry shown on the season ticket.
31. The season ticket shall be displayed upon the vehicle in the relevant position such that the expiry date and registration mark are clearly visible at all times that the vehicle is parked in the parking place.
32. Season tickets shall at all times remain the property of the Council, and shall be returned to the Council within seven days after the expiry of the period for which they are valid.

#### Exemptions from payment of the daily charge

33. No daily charge shall be payable in respect of :
  - (i) a vehicle which displays in the relevant position a valid disabled person's badge provided that the vehicle immediately before or after the act of parking has been used or is about to be used by the person(s) in respect of whom the badge is issued;
  - (ii) a motor cycle parked in a motor cycle bay ; or
  - (iii) a vehicle displaying in a relevant position a season ticket valid for that vehicle, that time and that parking place.

## **PART IV MOVEMENT AND RELOCATION OF VEHICLES**

#### Movement or removal of vehicles

34. (1) If a vehicle is parked in a parking place in a position other than in accordance with provisions of this Order, a person authorised by the Council in that behalf may alter or cause to be altered the position of the vehicle so that its position is in accordance with the said provisions.
- (2) If a vehicle is parked in a parking place in contravention of any of the provisions of this Order, a person authorised by the Council in that behalf may remove the vehicle from a parking place or arrange for such removal.

- (3) For the purpose of meeting the requirements of an emergency, a person authorised by the Council or a Police Officer in uniform may alter or cause to be altered the position of a vehicle in a parking place or remove or arrange for the removal of the vehicle from a parking place.
- (4) Any person altering, or causing the alteration of, the position of a vehicle by virtue of paragraphs 1 or 3 of this article, or removing or causing the removal of, a vehicle by virtue of paragraph 2 or 3 of this article, may do so by towing or driving the vehicle or in such other manner as he thinks necessary to enable the position of a vehicle to be altered or the vehicle to be removed.
- (5) Any person moving or arranging the removal of a vehicle by virtue of paragraph 2 or 3 of this article shall make such arrangements as he considers to be reasonably necessary for the safety of the vehicle in the place which it is removed.
- (6) Any reasonable cost incurred by the Council in securing the moving of, removal of and safe custody of any vehicle found in contravention of provisions of this Order shall be recoverable from the owner of the vehicle in accordance with relevant legislation.

## **PART V**

### **CONTRAVENTION AND PENALTY CHARGE**

#### Contravention

35. Save for the provisions in Part VI, if a vehicle is parked in a parking place without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable.
36. A penalty charge notice may then be served and/or the vehicle may be removed from the location.

#### Restriction on removal of notices

37. A penalty charge notice fixed to a vehicle shall not be removed or interfered with except by or under the authority of:
  - (i) the Owner, or person in charge of, the vehicle;

- (ii) the Council for the parking place in which the vehicle in question was found.

#### Indications as Evidence

38. The particulars given in a penalty charge notice issued in accordance with the provisions of this Order shall be treated as evidence in any proceedings relating to failure to pay such penalty charge.

## **PART VI OTHER PROVISIONS**

#### Liability to prosecution

39. Any person committing an offence according to the provisions of this part of this Order shall be liable to prosecution.

#### Licence and road tax

40. No person shall drive a vehicle into or in a parking place unless:-
- (i) he is the holder of a licence authorising him to drive a motor vehicle of its class or description on a road, or
  - (ii) he is the holder of a provision licence and is accompanied in that vehicle by a person holding a licence of the type mentioned in (1) above.
41. The driver of the vehicle shall not permit that vehicle to park in a parking place unless the vehicle is licensed in accordance with the provisions of Section 1 of the Vehicles Excise and Registration Act 1994 and unless there is in relation to the use of the vehicle by the driver such a policy of insurance as complied with the requirements of the Road Traffic Act 1988, as amended.

#### Use of parking place

42. No person, without the written permission of the Council, shall use any part of a parking place or any vehicle parked in a parking place:
- (a) for recreation or sleeping or camping or cooking, or

- (b) for the purposes of advertising or promoting any cause, event or other matter whatsoever or for the distribution of leaflets or other materials, or
- (c) for the erection of any tent, booth, stand, building or other structure, or
- (d) for the playing of ball games, or
- (e) for roller-skating, skate boarding, go-karting, the use of mini-motorbikes or
- (f) for the purposes of operating radio controlled machines.
- (g) or for any other purpose other than the designated purpose for the parking place.

43. In a parking place no person shall:-

- 1) light or cause or permit to be lit any fire;
- 2) fill any vehicle or container with petrol, diesel, oil or other form of fuel or inflammable liquid;
- 3) soil or defile, remove, displace or damage any wall or fence in or enclosing the parking place or any building, barrier, post, notice, sign, railing or other erection therein;
- 4) throw down, drop or otherwise deposit in any parking place any item or article of rubbish or waste material so as to contribute to or tend to lead to the defacement of that parking place by litter.

#### Not sound horn

44. No person in a vehicle using a parking place shall sound any horn or other similar instrument except when about to change position of a vehicle in or depart from the parking place.

#### Drive in specified direction

45. Where in a parking place signs are erected or surface markings are laid for the purpose of

- (a) indicating the entrance to or exit from the parking place, or
- (b) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place,

no person shall drive or permit to be driven any vehicle

- (a) so that it enters the parking place other than by an entrance, or leaves the parking place otherwise than by an exit, so indicated, or

- (b) in a direction other than so specified.

#### Parking purposes only

46. Save as provided in this Order no persons shall, except with the permission of a person authorised by the Council in that behalf, drive or permit to be driven any vehicle in a parking place for any purpose other than the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place.

#### Car park full

47. No person shall except with the permission of any person authorised by the Council drive any vehicle into a parking place when there is exhibited at the entrance to that parking place a notice indicating that the parking place is full.

#### Supermarket trolleys

48. No person shall leave any trolley, basket on wheels or other similar receptacle designed for the carrying of merchandise in such a position in any parking place so as to cause an obstruction nuisance or annoyance to other users of the parking place but shall ensure that such trolleys, baskets on wheels or receptacles are returned to the premises of the owners of such trolleys, baskets on wheels or receptacles or to such collection points in the parking place as may be provided by the said owners or by the Council.

#### Nuisance

49. No person shall do anything to interfere with the use and enjoyment of any parking place by other users of the parking place and in particular no person shall obstruct or misuse any of the ramps, stairs, doors or lifts in a multi storey parking place.
50. No person shall in a parking place wantonly shout or otherwise make loud noise to the disturbance or annoyance of users of the parking place or residents of premises in the neighbourhood.
51. No person shall in any parking place use any threatening, abusive or insulting language, gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned.

### Right of way

52. No person shall use a parking place as a means of passage or of proceeding from one road to another road.
53. Save as provided in this Order the right of passage within a parking place provided by the Council is available to a person driving or being conveyed in motor vehicles and does not extend to pedestrians other than the drivers of vehicles and their passengers leaving or returning to their vehicles and no rights of way whatsoever over the said parking place other than for the purpose of parking or removing vehicles shall be deemed to have been granted by the Council.
54. Nothing in this Order shall render it unlawful for pedestrians or persons driving or being conveyed in any vehicle to exercise the right of passage over a right of way formally agreed and approved by the Council over any parking place provided by the Council.

### Action after accident

55. If in any case owing to the presence of a vehicle in a parking place an accident occurs whereby personal injury is caused to a person other than the driver of that vehicle or damage is caused to a vehicle other than that vehicle or to any other property whatsoever, including the parking place, the driver of the vehicle shall stop if required to do so by a person authorised by the Council in that behalf or any other person having reasonable grounds for so requiring giving his or her name and address and also name and address of the owner and the identification marks of the vehicle and his or her certificate of insurance.

### Cycling

56. No person shall ride or cause to be ridden any pedal-cycle or tricycle in any parking place.

## **PART VII** **REVOCATIONS**

### Revocation

57. The following Order and its amendments are hereby revoked:
